Contact an arborist/ Secure large branches (cable) / Redo cavity work / Contact township / Open up area around tree / Remove sucker branches / Trim hedges around tree / Install weed mat at base of tree / Install hardwood mulch / Create pamphlet about tree with name of arborist / Grow saplings from acorns and donate to Society for fund raising / Create back-up plan if no acorns are available

Review the Warrington Landscape Ordinance / Review the old arborist report on file / Create sustainable plan / Record steps for annual follow-up / Contact Del Val College arborist-botanist professor

Contact John Bonargo (township public works supervisor) / Obtain county recognition / Contact Bucks County Planning Commission / Investigate township tree preservation / Contact Jeff Marshall upon receipt of Kaitey's plan / Consider Honor Society volunteers for future projects
