# Warrington Township Historic Commission Minutes:

- 2. Welcome Guest(s) and Public Comment Tom Whelan, who is a prospective volunteer; observed meeting and met committee members
  - a. No other public comment
- 3. Approval of Minutes Jan. 14, 2013 (no 2013 Feb. minutes; no business)
  - a. Historic Commission Minutes were approved unanimously
- 4. Gwyn noted letter (sent by Jerry Anderson) re: start meetings with Pledge of Allegiance and include public comment in meeting agenda
- 5. Gwyn read 2012 Commission Results document (sent to Tim Tieperman; shared with the BOS at the 2-12-13 meeting); Gwyn to e-mail it to members

- 6. Gwyn spoke about the 2-6-13 EAC meeting she attended; Gwyn will e-mail her EAC presentation notes; Gwyn spoke about the EAC meeting content and culture; possible project collaboration with EAC i.e. signs for township trails (with historical details) and Illg's property development
