### APPROVAL OF February 2023 MINUTES AND POSTING TO WEBSITE

- As member of Bike and Hike Committee, remind all of Bike and Hike Fish Day near the end of April
- Personal comment of positive outlook and looking forward to working with Park and Recreation Board cooperatively

#### PRESENTATIONS by GROUPS or INDIVIDUALS

- 1. **Warrington Warwick Softball Organization** (Eric Pincus President / Ken Griffin Treasury, Ellie Vice President)
  - Thank you for temporary fix of fence
  - >350 girls in spring league (>300 intramural, ~40-50 travel), also draw from neighboring communities
  - 60% Warrington, 20% Warwick, remaining outside communities
  - Blue Thunder is the travel program
  - Lights: Presentation made during pandemic
    - Boys Baseball Fields have lights
    - Girls do NOT

- Girls helped with lights on two boy's fields and split costs
- Twp funded 50%, Boys paid 50% (over 5 year period)
- Request lights for two fields for Girl's Softball
- Prior 2020 quote for
  - \$175 \$195k / field (inclusive)
  - \$105 \$125k / field (just lights)
- Next step: Get Updated Quote
- Dan encourages partnering with Baseball and also work with Private Donors
- Musco (sp?) Lighting: for ideas of foundations to request for funding (the twp as owner of fields would need to make funding request, this needs to be investigated)
- Still drainage issues on the fields (majors)
- Rain can put the out for day or two
  - Repairs can be costly and time consuming
  - \$5k spent on recent maintenance

- e. Andy also evaluating same idea. Examples in neighboring Dresher and Blair Mill Parks in Montgomery county.
- f. Joanne would like to incorporate our twp "Gateway" theme as part of improving and rebranding our neighborhood parks.
