## 1 & 2 Call to Order/ Pledge of Allegiance:

#### 5. New Business

a. Review and comment on a sketch plan for Carmel Cafe, Building 1100, Valley Square Doug Waite (Gilmore & Associates) and Moffat Welsh (Wilder Management) were present to represent this application this evening. The plan is to use the existing store, unit 1100, but never occupied since built. The plan calls for the main entrance to be moved to the north side and an outside eating are added. The dumpster would need to be relocated and the existing parking lot is to be used. They will require a waiver because the seating area will be in the building setback along Valley Square Blvd. Originally, there was to be a roof over the outside area, but the roof needed to be eliminated to keep it from being considered a building.

There have been storm water issues in the area that is to be the outside area since the original construction. This problem will be corrected regardless of the decisions of for this project. The NE corner landscape wall will be moved and the water will be diverted to the underground basin using a retrofitted storm water system. The 8 inch outlet pipe will be replaced with an 18 inch poly pipe that will reroute the water to the underground basin in the parking lot.

A motion was made by Mr. Rycharski, seconded by Mr. Redd, to recommend to the Board of Supervisors minor subdivision with the following conditions:

- Compliance with the Carroll Engineering letter of 6/14/2013
- Applicant has agreed to notify the neighbors when any further applications are submitted
- Demolition of the existing structure must be complete before the issuance of any further permits

b. Review and make recommendations on a plan for a lot line change plan for the Wagner properties, Tax Parcel Nos. 50-032-024 and 50-032-024-001.

Bruce Nickerson (attorney) and the applicants were present this evening for this application. This was submitted as a lot line change for the property at Kansas Rd and Maple Ave. These are currently nonconforming lots, but with the line change they will be conforming for the size of the lots for the zoning designation. They will still be nonconforming with impervious coverage and setbacks.

There is a note on the plans that prior to any building permits being issued; the house and small garage will be removed from lot 1.

There was extended discussion regarding if this was a lot line change or a minor subdivision.

A motion was made by Mr. Gordon, seconded by Mr. Gaines, to recommend to the Board of Supervisors approval for the Wagner Lot line change at the corner of Kansas and Maple Ave, with the following conditions:

• Compliance with the Carroll Engineering letter of 6/6/13 regarding monumentation.
